

Privacy policy - The Scout Association of Croatia

Privacy policy

This Privacy Policy explains how the Scout Association of Croatia (hereinafter referred to as: "Scouts Croatia") processes your personal data. Scouts Croatia is focused on protection of your personal data and their processing in accordance with the General Data Protection Regulation and the Croatian Law on Implementation of the General Data Protection Regulation. Please read these rules carefully in order to understand why and how we are collecting your personal data and how we intend to use it.

Scouts Croatia is data controller of your personal data. We have a data protection officer and you can contact us via e-mail: sih@sih.hr or on address: Koturaška 3a, 10000 Zagreb.

Purposes of the processing of personal data

Your personal data is processed because of the legal requirements, or processing is necessary for the performance of a contract or in order to take steps prior to entering into a contract or for the purposes of our legitimate interests, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subjects which require protection of personal data.

If personal data cannot be processed based on aforementioned legal basis we will request your consent. While communicating through an e-mail based on a legal interest, you can notify us at any given time that you do not want to receive our e-mail. You can do that by replying to an e-mail from which you have received the message. If processing is based on your consent, you have the right to withdraw consent at any time. You can notify us about the withdrawal of the consent at any given time via e-mail address: sih@sih.hr or via address: Koturaška 3a, 10000 Zagreb. Such withdrawal will not have an effect on the lawfulness of processing based on consent before its withdrawal.

Your personal data is processed only when it is necessary to fulfil rights and obligations that will arise from business relations, for marketing purposes or for improving our businesses and your user experience.

Personal data is mostly collected directly from you when you fill out a specific form or trough public available information.

Personal data categories

The Scout Association of Croatia collects personal data for the unique identification of users when realizing the Project for the reparation of fired areas of Dalmatia - "BORANKA", project analysis and implementation, marketing, product delivery, newsletter documentation and other types of technical support.

When a user engages in specific activities on the www.boranka.hr web site, such as virtual tree planting and / or donation payments, posting comments, publishing content, participating in other activities related to the Reparation Areas Project of Dalmatia - "BORANKA", sending feedback, Scouts Croatia may ask the user to provide certain additional personal information. In that case, prior to providing additional personal information, the user is required to review this Privacy Policy and agree to their use with respect to additional information.

On the web site www.boranka.hr , Scouts Croatia collects personal information of the respondents such as name, age, gender, email address, zip code, city, IP address, language of agreement and username.

When entering into business relations we need information about appointed contact person for communication with Scouts Croatia, especially name, surname and e-mail address. We collect personal data that you provide by filling out online forms (name and contact) or when you give us your consent to include your data in our list so we can send you newsletter or other interesting materials.

Basis for the processing

Controller can process personal data only and to the extent of the following basis for the processing: the data subject has given consent to the processing of his or her personal data, processing is necessary for the performance of a contract to which the data subject is party or in order to take step at the request of the data subject prior to entering into a contract, processing is necessary for compliance with a legal obligation to which the controller is subject, processing is necessary in order to protect the vital interests of the data subject or of another natural person, processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller, processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data, in particular where the data subject is a child.

Your rights

You have the following rights:

Right of access: you have the right to obtain from us a confirmation as to whether or not personal data concerning you are being processed, and, where that is the case, access to the personal data. Information's about access include but are not limited to – the purposes of the processing, the categories of personal data concerned, the recipients or categories of recipient to whom the personal data have been or will be disclosed. However, right of access is not an unconditional right and rights and interests of other individuals may limit your right of access.

You have the right to receive a copy of the personal data undergoing processing. For any further copies you request, we may charge a reasonable fee based on administrative costs.

Right to rectification: you have the right to obtain from us without undue delay the rectification of inaccurate your personal data. Taking into account the purposes of the processing, you have the right to have incomplete personal data completed, for example by providing a supplementary statement.

Right to erasure ('right to be forgotten'): under certain conditions, you have the right to obtain from us the erasure of your personal data and we are required to erase such personal data.

Right to restriction of processing: under certain conditions, you have the right to obtain from us restriction of processing your personal data. In that case, such data will be marked and can be processed only for certain purposes.

Right to object: Under certain conditions you have at any time the right to object to processing of your personal data, on grounds relating to his or her particular situation or when personal data are processed for direct marketing purposes you have the right to demand from us to stop the processing of your personal data.

Right to data portability: Under certain conditions, you have the right to receive your personal data,

which you have provided to us, in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller without our hindrance.

If you think that your rights have been violated you have the right to file a complaint with Croatian Personal Data Protection Agency.

Storing of personal data

Your personal data that is collected will be stored in a safe environment. Your personal data is protected from any unauthorized access, disclosure, use, alteration or destruction by any organisation or individual.

Information collected for aforementioned purposes will be stored only as long as it is necessary for the mentioned purposes. Your personal data will not be kept in a form that enables your identification longer than Scouts Croatia reasonably considers it is necessary to fulfil the purpose for which they have been collected and processed. Scouts Croatia will store certain personal data for a period of time that is laid down by law or regulation binding Scouts Croatia to store data.

If you have given us your consent, your personal data will be processed until consent is withdrawn. If you file a grounded objection against the processing of personal data based on legal interest your personal data will not be processed in the future.

Personal data can be processed until the end of a court, administrative or extrajudicial proceeding, including the period for submitting legal remedies. MEDIA VAL shall keep certain personal data for a period of time that is laid down by law or regulation binding the controller to store data.

Recipients of personal data

With aforementioned, your personal data can be given to our trustworthy partners who maintain our IT system or provide services in the name of Scouts Croatia (Imago reklamna agencija d.o.o., Ulica grada Vukovara 271, Zagreb, Degordian d.o.o., Vukasovićeva 1, Zagreb). Examplewise, for marketing, finance, advertising, payment processing, delivery and other services. Aforementioned service providers are obligated, according to relevant contracts, to use the entrusted data only in accordance with our regulations and exclusively for strictly declared purposes. They are also obligated to adequately protect your data and to keep your data a personal and professional secret.

Cookies

We will keep and evaluate information about your recent visit to our web sites and how you used different parts of our web sites for analytical purposes, respectively in order to understand in which way users are using our web sites.

In order to maintain your web site and to ensure its functionality are on the expected level, Scouts Croatia uses technology known as "cookies". Cookies are small files that are sent to your computer and can later be accessed. They can be temporary or permanent. Thanks to cookies, you can search our web sites without difficulties and access information that are relevant for you. Cookies show us what you and other visitors of our web sites are interested, and in that way, we can improve our web sites.

We process cookies only with your consent. To withdraw or agree to the use of cookies, make the appropriate settings in your browser. However, some of our website features may not function without cookies.

Marketing

Scouts Croatia would like to send information about our activities and services, which we think you may find interesting. You have a right at any time to stop us from contacting you for marketing purposes.
